

TERMS AND CONDITIONS

1. Introduction

Welcome to **renatatotart** (“Company”, “we”, “our”, “us”)!

These Terms of Service (“Terms”, “Terms of Service”) govern your use of our website located at **renatatotart.com** (together or individually “Service”) operated by **renatatotart**.
